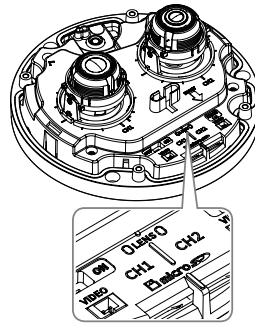

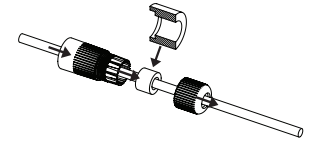

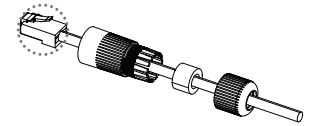

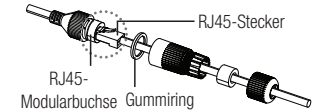

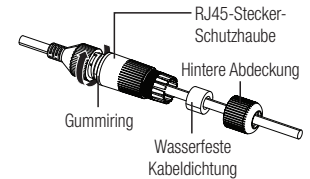

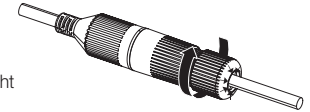

Einbau im Außenbereich

Wenn Sie die Kamera draußen installieren, soll diese mit wasserfestem Butylkautschukband befestigt werden (welches in den Läden erhältlich ist), sodass das Wasser nicht in die Spalte zwischen dem Kabel und der äußeren Verbindung eindringt.

1. Verbinden Sie das PoE-Kabel.
2. Die schwarze Kabelummantelung (Bereich A) und den Kabelanschlussbereich mit dem wasserundurchlässigen (Butylisolier-) Band so umwickeln, dass mehr als die Hälfte des Butylisolierbandes überlappt wird.



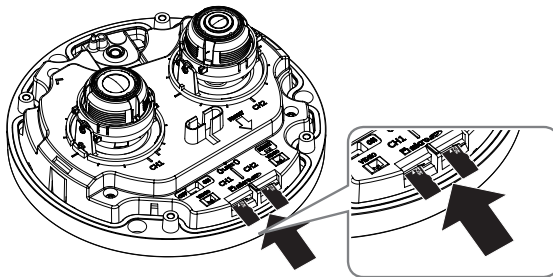

- Das wasserdichte Butylklebeband besteht aus Butylkautschuk und kann auf das Doppelte seiner normalen Länge ausgedehnt werden.

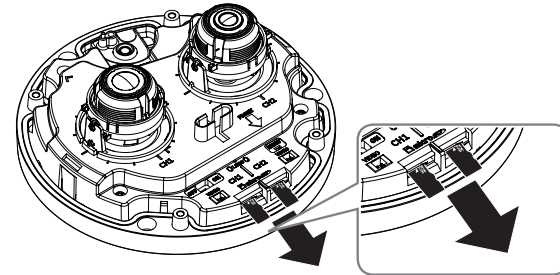

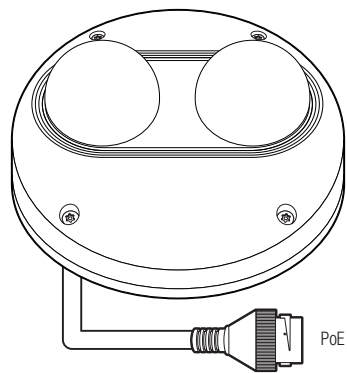

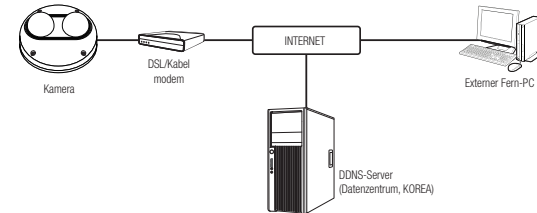
Anschluss an die Kamera von einem lokalen PC im LAN

1. Starten Sie einen Internetbrowser am lokalen PC.
2. Geben Sie die IP-Adresse der Kamera in die Adressenleiste des Browsers ein.

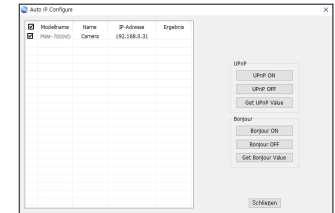

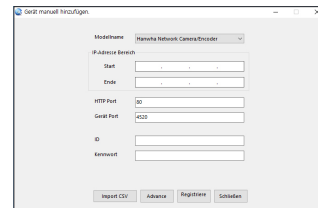

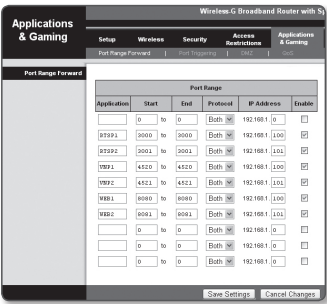


PORTBEREICHWEITERLEITUNG KONFIGURIEREN (PORT MAPPING)

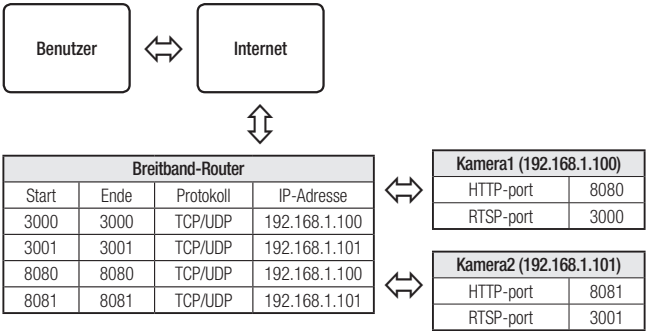

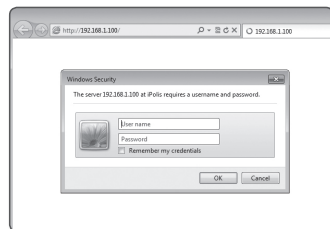

PLUG-IN-SPEZIFIKATIONEN FÜR JEDEN BROWSER

Der neue Web Viewer ist Plug-in-frei.

Dies macht es möglich, den Web Viewer auch in solchen neuesten Browserumgebungen einzusetzen, die Plugins wie Chrome, EDGE und FireFox nicht unterstützen (nur für Windows 64bit). Die folgenden Abweichungen treten abhängig von Ihrer Browserumgebung auf:

- Chrome-, FireFox(Wird nur bei Windows 64bit), EDGE, Safari-Browser** : Obwohl diese beiden Browser keine Plug-ins unterstützen, können Sie einen Web-Viewer nutzen, da ein kostenloser Plug-in-Web-Viewer integriert ist.



- Da der Plug-in-freie Webviewer eine geringere Leistung als der Plug-in-Webviewer hat, besteht ein Limit bei der Überwachung von Profilen mit hoher Qualität und der Wiedergabe gespeicherter Videos. Um Profile mit hoher Qualität zu überwachen und gespeicherte Videos wiederzugeben, verwenden Sie bitte einen Plug-in-Webviewer oder einen SmartViewer.
 - Plug-in-freie Web-Viewer-Erstellungsbedingungen: Das ausgewählte Profil überschreitet MJPEG Full HD 10fps H264 (Chrome: Vollbildschirm unterstützt / Edge, Firefox, Safari : Full HD 30 fps oder höher) H.265 FullHD 10fps 2Mbps oder höher
 - Plug-in-freie Wiedergabebedingungen: MJPEG / H.264 Vollbildauflösung, H.265 HD oder niedriger
- Die Plug-In-Funktion wurde für den Chrome-Browser optimiert.
- Unterstützt Adaptive Streaming
 - Dies ist die Funktion, die das Profil automatisch senkt, wenn es eine Verzögerung von mehr als 5 Sekunden gibt. Es wurde gemacht, um Probleme wie erhöhte Latenz und keine Reaktion aus dem Browser bei der Wiedergabe des Videos auf einem System mit niedrigeren Hardware-Spezifikationen als empfohlen zu verhindern. Das Videoprofil wird in folgender Reihenfolge reduziert: 1920X1080(20fps) -> 1280X720(20fps) -> 640X480(20fps).
